#### **Minutes of November 2011 Board Meeting**

As BYSL President, Dean Cook made a sincere apology to all those parties affected by the decisions made by Mark Oliver and agreed to appoint a Junior High Program Judicial Committee to hear all alleged violations, review any alleged misconduct, and administer any subsequent disciplinary actions.

As per BYSL Jr. High Program Rules and Regulations, this committee shall consist of representatives of the Jr. High Program teams, as selected by the BYSL Discipline Committee Chairperson. The number of members on this committee shall be greater than two, but not more than the number of teams represented in the current 2011 Jr. High program.

**New Business.** The following ideas were presented for discussion:

1. Brigham Redd noted that there is a deficit of tournaments in Idaho in June and July and could Idaho's lack of summer tournaments be changed/addressed to provide our soccer players more competition. Surrounding states do hold numerous successful tournaments throughout the summer.
2. Maurya Bourgeois discussed extending the length of the YDP fall season.
3. A discussion was held on the potential for another indoor soccer facility in Idaho Falls. Dean Cook reminded us that we still need to use our money for the completion and improvement of our outdoor fields before we can entertain the idea of new indoor facilities.
4. A notice of new AGM Bylaw changes was given.

Dean Cook adjourned the meeting.
