SRL SHEET INSTRUCTIONS & DATES OF INTEREST

1. Complete and return attached IYSA DISTRICT II SRL Commitment Sheet no later than Friday, **February 19th, 2010**. Hard Copies are required; phone calls WILL NOT be accepted.
2. Saturday play is very limited:
 - a. Reminder: Tournament dates are listed in the middle of the page. If you commit to Saturday play, please make sure you have not already committed to a tournament.
3. SRL **DRAFT** Schedule will be completed by early March (for your review).
4. Once the schedule is posted, please review any all potential conflicts with your schedule.
5. You will have until **March 12th** to let Dean know of any conflicts
6. Once the final revision of the schedule is out, no later than **March 17**, ANY CHANGES, CANCELLATIONS, (NON-WEATHER RELATED) will cost you (the coach/affiliate) **\$50.00**.
7. If your team is traveling out of the area (i.e., Pocatello to IF), it is HIGHLY recommended that you (the coach/tm) contact the opposing coach prior to traveling to confirm their team will be there. (Not every coach reads the schedule faithfully, and there could be some changes they are not aware.)
