B. Junior High Program:

E. **Treasurer** - No Report, invoice for YDP medals (\$374) and Junior High Trophies (\$300). There is a concern that several players are playing without having paid their fees. Dan/ Judy/Bobbi are working to identify those players and speak with the coaches.

F. **Registrar** - We will be using GotSoccer for the Fall, Dan would like it to be mandatory for everyone to use GotSoccer for the Fall. This will allow our coaches to have lists of players prior to the tryouts. Dan will hold time at his office for players/parents that don't have access to a computer to sign up. The Board/coaches/etc. will have to get the word out that GotSoccer will be required for registration. Players will pay a \$40 tryout fee at registration.

G. **Shootout** – We have asked for approval on our dates for IYSA for the 3rd weekend in June.

H. **Website - No Report**

I. **Equipment** – Dan has received a request for a donation for work to help install the shed and some materials. Dan is going to check with the City to make sure they are still willing to allow us to put up a shed at Sunnyside Park.

J. **Far Post** – Bobbi will be working on the **Far Post** this weekend. Indoor registration is starting soon for the **IF YMCA**. There is also a Futsal league starting in Rigby.

K. **DII**- Calendar Year switching, Craig wants to get out as much information as possible. The district has a meeting in November. DII will also be discussing Risk Management at the meeting. The **IYSA State** Director of Instruction will be Peter Stilling starting in October. John McGimpsey is the new DRA, **and he is planning on having another USSF course in the not too distant future to try to get more referees and an instructor in our area.**

Spring Coach List- Approval of Spring 2016 coach/team lists for publication in the Far Post. Motion to approve current coaches listed by **Jason** Lance, seconded by Scott Staker. Motion passed unanimously. Motion to include Godoy made by Wes Stumbo, Seconded by Abe Romo. Motion passed unanimously but with a note from Bobbi that we need to get settled on the “year” grace period.

With the new licenses being available on-line; i.e., the USSF F and the NSCAA Level 1, the board needs to decide if there should be a new “minimum” license requirement and for what age groups? We will discuss this next week.

Request by Jackson United for friendlies against our Jr. High teams (home games on Oct 17/away games on Oct 24) 2 Boys and 2 Girls. There was no concern about the junior high teams having this option.

Risk Management – Pete Nawrocki – US Youth Soccer has limited resources. US Hockey uses Team USA.org and a program called SafeSport. This is a free course that is on line and IFYHA requires ALL adults that are in contact with players to take this course and provide proof of their completion. Dan’s recommendation is that all board members and all club presidents take the Safe Sport course **during September** to report at the October meeting to decide how to move forward.

Recruiting Question – There seems to be an inconsistency between the new recruiting rules and the jr. high rules of when and who can recruit. Dan will research further and make a recommendation to help improve and/or clarify these rules.

2 Adults Per Team – We will require any adults that will be helping with try outs to **have their** paper work and background checks in. If your 2nd adult is not going to be helping with tryouts then **their background checks** must be completed prior to team registration.
