Discussion:

1. Trina Clegg presented and vouched for several coaches, including those noted below. Ed Espinosa and Cynthia Lopez attended and introduced themselves.
 - a. Trina also requested information for upcoming coach training sessions so that her assistant coaches can be further trained.
2. Trina Clegg discussed the Liga Latina's move from the Starlight Arena to the YMCA. Games are on Sundays and is open for adult teams and older teenage teams. She requested BYSL inform BYSL teams of the league so they can fill the league schedule.
 - a. Action item – Jason Child or Brandon Lee to revise and forward email to BYSL coaches informing them of the Sunday league after Trina sends them a summary email with full information.
3. Trina presented Jeff Edwards as a potential board member and he was advised of the November elections. Trina also presented the name of Craig Thomas, not present, as another possible Board member.
4. Tryouts
 - a. Trina reiterated her request that Club tryouts be in June rather than October.
 - b. Dates – the board discussed holding tryouts October 23-25 for U14+ club tryouts and October 26-27 for U13 tryouts. U14+ would have non-tryout team sessions on October 23-24 and tryouts on the 25th.
 - Action items – Jason Childs to check for lights availability on October 23-27. Jason Childs to advise players and coaches of confirmed dates and times.
 - c. The Board discussed having an on-site setup to collect tryout fees from those who have not already paid.

- d. The Board selected Monday the 16th to interview prospective U13 coaches.
 - Action item – Jason to reserve Broulim’s room for interviews, if available, and advise potential coaches of the date and time.
- e. Action item – Bryce to work on advertising the tryouts through various media.
